In the order , Smt.P.U.Rajeswary Accounts Officer , District Project Office, SSA, Ernakulam was transferred and posted as Accounts Officer District project Office, Idduky. But she has ^a filed WP(C) No.18121/2011 before the Hon'ble High Court of Kerala against her transfer and the Court as per order read as Second paper above stayed the transfer for 3 weeks. So also Sri. P. Premachandran, Administrative Assistant, office of the Deputy Director of Education, Thrissur. who is under orders of

transfer to the office of the Deputy Director of Education, Kollam has failed WP(C) No.17863/2011 before the High Court of Kerala against his transfer and the Court as per Order read as 3rd paper above ordered that the petitioner shall be allowed to continue at Thrissur. In this contest, as per the letter read as 4th paper above the Director of Public Instruction, has suggested some modification to Government Order read as 1st paper above to overcome the Administrative problems created by the Court Order in the transfer and postings of Officers in the cadre of AA/AO/APFO in the Education Department. 
