ORDER

As per the letter read above, the Director of Public Instruction has informed Government that the posts of Text Book Officer and Senior Administrative Assistant (Noon Meal) could not be filled up as there are no eligible candidates in the select list approved by the DPC (H) held on 20.04.2011 as the incumbent who are eligible for promotion according to seniority has not declared their period of probation in the feeder category. For the smooth functioning of text book printing and distribution and for the smooth conducting of noon meal programme in the state without giving room for complaint, the Director of Public Instruction has recommended 3 senior most persons in the feeder category, for temporary promotion to the cadre of Text Book Officer and Senior Administrative Assistant (NM) as per Rule 31 (a) (i) of KS & SSR.

2. Government have examined the matter in detail and are pleased to accord sanction for the promotion of the following officers to the cadre of Text Book Officer and Senior Administrative Assistant (NM) as per Rule 31(a)(i) of KS & SSR in the scale of pay of Rs. 24040 - 38840/- in the Education Department with immediate effect.

(i) Sri. P.Achuthankutty, Accounts Officer, office of the District Project Officer, Sarva Shiksha Abhiyan, Palakkad is reverted to the parent department and temporarily promoted to the cadre of Text Book Officer and posted as such.

(ii) Smt.K.Jameela, Administrative Officer (PF) is temporarily promoted and posted as senior Administrative Assistant (NM), office of the Director of Public Instruction, Thiruvananthapuram.

The deputation to Sarva Shiksha Abhiyan will be filled up from the cadre of Accounts Officer, after following the procedure.
