ORDER

As per GO read as 1st above IT Department has been nominated as Nodal Department for the work relating to UID project. A Cabinet Subcommittee to oversee and guide the implementation of the project and a State UID Implementation Committee has been constituted, vide G.O. read as 2nd and 3rd above. For the implementation of the UID project MOU, has also been signed between Government of Kerala and UIDAI.

As per GO read as 4th paper above, a Committee of Secretaries has been constituted to discuss the need and scope of KYR plus data for Kerala and to finalize the scope of such data. The Committee held its meeting on 22.07.2010 and made the following recommendations for implementation of the UID project in the State.

- I) The Committee Proposed the draft KYR+ format and as regards development of software application for collecting KYR+ will be done by State Government.
- II) The Committee proposed to set up a UIDAI - Registrar Joint Working Group with following Composition from each side:--
 - i. Nodal Officer
 - ii. Technology Manager
 - iii. Project Manager
 - iv. Application Manager
 - v. IEC Resource

Besides these there would be a State Resource Person and a Bank Representative (for financial inclusion)

III) The Committee proposed to create a Kerala UID project to assist Government to perform its role as Registrar for the UID Project in the state. The Project would be headed by a Project Head, who shall be the Nodal Officer for the state Government side, who would be assisted by the officers listed in the Joint Working Group as above. It was also suggested to create the following posts for the purpose with scale of pay as below:-

| ii) Technology Manager- | Consolidated pay of Rs. 50000/- per month or equivalent scale of pay. |
| iii) Project Manager- | Consolidated pay of Rs. 50000/- per month or equivalent scale of pay. |
| iv) Application Manager- | Consolidated pay of Rs. 50000/- per month or equivalent scale of pay |

IEC Resource may be shared from existing resources of KSITM.

IV Till such time full-time persons are posted in the UID Project Team, Director , KSITM may be nominated as the Nodal Officer and Shri. Suneesh, Manager, KSITM, as Project Manager, in view of the need to start the project . Other personnel shall also be identified from within KSITM who will discharge this responsibility in addition to their existing responsibilities.

V The Committee proposed that KSITM shall provide about 500 sq. ft. space for the Kerala UID project for setting up of the office for UID project as well as for setting up of demonstration units.

- VI As regards identification of Enrollment agencies, the Committee proposed that the three agencies which could be identified as Enrollment Agencies may be KELTRON, IT @ School and Akshaya and they may be offered upto Rs.20/- towards collection of the data.
- VII The amount which will be reimbursed by UIDAI @ Rs.50/- per individual may be used by the state government for expense towards enrollment and such other expenses as required to fulfill its role as Registrar. It was also suggested that the amount may be released by UIDAI to KSITM in the name of Kerala UID project to be operated jointly by the Kerala UID project Nodal Officer and the Project Manager. It was also agreed that an account in the nationalised bank may be opened by KSITM in the name of Kerala UID project.
- VIII The 13th Finance Commission has approved to provide funds @ Rs.100/- per BPL individual enrolling for UID. It was agreed that a part of the amount may be provided as incentive to the BPL category for getting their UID.

Government have examined the matter in detail and are pleased to approve the recommendations made by the Committee of Secretaries as detailed above for the implementation of the UID project in the State.
