The appointment of the above person as HM are purely on provisional basis subject to the condition that they shall not by reason of this appointment be regarded as a probationer in this service class or category nor they acquire there by any preferential right for further appointment to the next service class or category. They will however be entitled to the monetary benefits attached to the post. The provisional promotees will not be regarded as a probationer in the category of Headmaster till they are promoted on a regular basis as per General seniority list of HSAs.

The Head of the institution will ensure that the promotees have passed Account Test (Lower) and KER conducted by the KPSC and have 12 years continuous grade service as on the date of this order. If there is any doubt, the promotees should not be relieved and the fact should be reported to this office immediately for further instruction.

The Heads of the Institutions will relieve the persons under orders of promotion within 7 days with directions to report for duty at their new stations under intimation to this office.

Application for Transfer will be considered only after joining in the new station. RTC should be forwarded to all concerned as usual.

The Promotion Order will be published in the official website of Department ([www.educationkerala.gov.in](http://www.educationkerala.gov.in) in DPI announcements). No individual communication to the incumbents from this office. The controlling officer is directed to download the order and distribute the copies to the concerned persons accordingly. The Promotion of Headmaster is purely on provisional. The provisional promotion of the HSA as HM now ordered is liable to be changed/cancelled if any discrepancy is found by the undersigned.
