I have been directed to invite applications for filling up 01 post of Additional Director (Primary Education) on urgent basis in the General Wing of North Delhi Municipal Corporation from eligible and willing officers working in the Level-12, (Rs 78800-209200) of Pay Matrix in VII CPC (equivalent to Scale of Rs. 15600-39100 + Grade Pay Rs. 7600/- in Pay Band-3 in VI CPC) for last 5 years on regular basis along with having requisite qualifications on deputation basis.

Eligibility Conditions for transfer on deputation:- As per the DoP&T guidelines 5 year's regular service is required for transfer on deputation to the post of Additional Director (Primary Education) in North DMC in Level-13, (Rs 118500-214100) of Pay Matrix in VII CPC (equivalent to Scale of Rs. 37100-67000 + Grade Pay Rs. 8700/- in Pay Band-4 in VI CPC) from the eligible officer in Level-12, (Rs 78800-209200) of Pay Matrix in VII CPC (equivalent to Scale of Rs. 15600-39100 + Grade Pay Rs. 7600/- in Pay Band-3 in VI CPC).

(a)	Officers of the Central/ State Govts./Union Territories:-
(i)	Holding analogous posts on a regular basis or;
(b)	Possessing following Essential educational qualifications and experience
(i)	Master's degree from recognized University or equivalent.
(ii)	Degree or post-graduate Diploma in Teaching /Education from a recognized University/Institution or equivalent.

The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion. Period of deputation/contract including period of deputation/contract in another ex-cadre post held immediately preceding their appointment in the same or some other organization/department of the Central Govt. shall ordinarily not exceed five year. The maximum age limit for appointment by deputation (including short term

Contract) shall be not exceeding 56 years as on the closing date of the receipt of applications.

Since North Delhi Municipal Corporation follows the Rules/Regulations and Instructions of the Govt. of India in regard to the pay/salary, allowances and other perks/benefits, the incumbent of the post will be entitled to all the perks/benefits which are admissible under the said Rules, Regulations and Instructions.

The terms and conditions of deputation as laid down in the Ministry of Personnel, Public Grievances and Pension, Govt. of India, Department of Personnel & Training C.M. DOP&T vide O.M. No. 6/8/2009-Estt.(Pay II) dated 17.06.2010 shall be applicable mutatis-mutandis.

(iii)	With 5 years' regular service in posts in the scale of Rs.3000-4500 in IV CPC revised to Rs. 10000-15200 in V CPC equivalent to Scale of Rs. 15600-391000 + Grade Pay Rs. 6600/- as far as scale of Assistant Education officer in MCD is concerned in Pay Band-3 in VI CPC and in Level-11, (Rs 67700-208700) of Pay Matrix in VII CPC.
