Headmasters have been provided with a user id and password for logging onto the State</p>	

	<p>of MDMS)</p>	<p>Portal daily at specified timings where they have to enter the number of students who avail mid day meal on the day. The data thus entered by the school headmasters is consolidated at the state level in “xml format” and uploaded to the portal of MHRD. The data is being uploaded to the central website of MHRD before 3 PM every day.</p> <p>Close to 50% of schools have been currently uploading the data. Majority of primary schools do not have net connectivity . State Government and Department of General education have initiated adequate steps for providing net connectivity to all schools in the State. Within a period of 6-8 months, all the schools in the State will be covered by the online daily data monitoring system.</p> <p>Further, a committee named school noon-feeding committee is formed in all schools which is responsible for the monitoring and management of the Scheme in the school. PTA president is the chairman and HM is the convenor of the committee. The committee also comprises of representatives of teachers, parents, mother PTA and the local ward member. The committee is convened once in every month. The committee reviews the progress of the implementation of MDM at the school level every month during its sitting and examines and clears the bills and vouchers of expenditure for the previous month to be submitted to the Block level office concerned for approval.</p> <p>An officer from the Block Level Office called Noon Meal Officer visits schools periodically and inspects the physical conditions and verifies registers and records. The visit report is submitted to District Authorities .If the District authorities find any serious issue in the reports, they report the matter to the State Level office via e-mail , phone or letter. A separate section is operating in the State level office where such complaints/issues are processed and prompt remedial actions taken.</p>

Ref. clause 2.6 r/w 4.2 &amp; Ann. 9 of MDMS), if yes give details.</p>	<p>Kitchen cum store rooms are constructed as per the guidelines issued by MHRD. Each kitchen cum store has two portions/area/rooms- one for the kitchen where the meal is cooked and the other for storing rice and condiments. Store rooms have adequate storage facility and have shelves. Proper ventilation is ensured. The building is constructed adhering to all safety standards. The engineering division of LSGD inspects and issues fitness certificate only if the building meets all requisite standards.</p> <p>The construction of 3031 kitchen cum store units will be undertaken shortly in the State. Funds (State Share) are being disbursed to schools. The construction is based on the typical plans downloaded from MHRD website and adhering to all the guidelines issued by MHRD in this regard. The typical plans and MHRD guidelines will be shared with schools and Assistant Educational Officers (Block level officers) and District Officers will be instructed to strictly monitor the construction and to ensure that it meets required standards.</p>

State Civil Supplies Corporation is the nodal agency in the State to lift the allotted food grains from FCI Depots and deliver it to schools uninterrupted. Central Government provides an amount of Rs.750/- per MT as transportation assistance to States. However for the smooth and efficient flow of foodgrains to schools, State Government is additionally paying an amount of Rs.1450/- per MT to State Civil Supplies Corporation as transportation assistance. Further, no delay occurs in releasing payment to FCI towards the cost of rice. Payment for the cost of rice upto 31.03.2017 was placed at the disposal of District Level Officers on 20.10.2016 with instructions to release the payment to FCI on the day of receipt of bills/vouchers. A grievance redressal forum has been constituted as per Order No. GO (MS)No.10/2011/GEEdn. Dated 19-1-2011 at state level with PTA members, representatives of teachers' organization, DPI, Local body authorities etc. The Telephone land line number and the e-mail Id of the Noon meal section in the Directorate have also been published to register the grievance. Directions will be given to the concerned at District/Block level to constitute a</p>	

		<p>grievance redressal forum.</p> <p>The management and monitoring of the scheme at the school level is being done by a school noon feeding committee that comprises of representatives of teachers and parents and the local ward member. Complaints with regard to the conduct of the MDM scheme at the school level can be submitted to the block level office. An officer in the cadre of Junior superintendent has been posted as Noon Meal Officer at each block level office who periodically visits and inspects schools under his/her jurisdiction and monitors the progress and conduct of the implementation of the scheme. He receives complaints and grievances, if any, from the public and takes appropriate action with intimation to the district authorities. If the issue is grave, he reports it to the district office or to the State office immediately via e-mail. The phone numbers and e-mail ids of block/district and state level offices are published and can be had from any school in the state.</p> <p>At the district level, an officer in the cadre of senior superintendent called Noon Feeding Supervisor is posted at the district office to supervise the activities of MDM in the district.</p> <p>A separate section consisting of a junior superintendent and three senior clerks is functioning at the State Office to address the grievances in the implementation of the scheme. The phone numbers and website address of the State Level Office have been published.</p>
