ORDER

As per Government Order read 1st as above the Government has sanctioned 25% Ratio Promotion to Junior Superintendents with effect from 01/02/2011. The Cadre Strength of Junior Superintendent and Store Keepers in this department as on 01/02/2011 were 285. **Accordingly, 71 senior most Junior Superintendents are eligible for Higher Grade with effect from 01/02/2011.**

As per Government Order read 2nd as above the Government have sanctioned 163 Noon Meal Officers posts in the Cadre of Junior Superintendent in the Assistant Educational Offices. Accordingly the Cadre Strength of the Junior Superintendent in this department is raised upto 448 with effect from 05/06/2015. **Therefore, Out of 448 Junior Superintendents 25% senior most among them (112) are eligible for Junior Superintendent Higher Grade (Ratio Promotion) (details shown below).**

In the above Circumstance the eligible Junior Superintendent as per the Seniority List of Junior Superintendents in this department are provisionally sanctioned Junior Superintendents Higher Grade in the Scale of Pay of **Rs. 18740-33680/-** (Pre-revised) with effect from the date noted against their names.

The Proceedings vide reference 9 read as above is modified accordingly and no change in the list.
