ORDER

In compliance of the judgment and the order of the Hon'ble High Court of Kerala read as 1st and 2nd paper read above, Government had issued guidelines for granting recognition to un-recognized unaided schools in the State following Kerala State syllabus vide Government Order read as 4th paper above and also decided to process applications received from the schools in compliance of the judgment read as 1st paper above.

The Director of General Education, Thiruvananthapuram as per the letter read as 6th paper above has forwarded the application of Santhom English Medium School, Thottumukkom, Kozhikode (PIN – 673 639) with recommendation for the recognition of class V to class VII. It is seen that the Government vide order read as 5th paper above had granted recognition under Right of Children to Free and Compulsory Education Rules 2011 for Santhom English Medium School for class I to class IV.

Government after examining the matter with reference to the application and recommendation of the Director of General Education and subsequent correspondences in this regard, hereby convey the grant of recognition to Santhom English Medium School, Thottumukkom, Kozhikode (PIN – 673 639) for class V to

class VII under Sub Rule(10) /Sub Rule (14) of Rule 14 of Right of Children to Free and Compulsory Education Rules 2011 for the purpose of Section 18 of Right of Children to Free and Compulsory Education Act 2009 with effect from the academic year 2019-2020 subject to the conditions mentioned in the Government Order read as 4th paper above.
