

The controlling officers/District Educational Officers are directed to admit the newly appointed Junior Superintendents in concerned DTBDs and then relieve with direction to report for duty before the controlling officers concerned in which their service are deployed on the same very date.
- 3) Officers who are promoted to the cadre of the Junior Superintendents/Noon Meal Co-ordinators/Noon Meal Officers/Store Keepers and Head Clerks will be on probation for a period of one year w.e.f the date of joining duty within a continues period of two years.
