- 1) The lien of the deployed Junior Superintendents in Text Book Office/District Text Book Depots maintained in the Text Book Office/District Text Book Depots itself. Their salary and allowances should be claimed and disbursed only through Text Book Office/District Text Book Depots until further orders in this regard.
- 2) The deployed incumbents are directed to report for duty before the concerned controlling officers/District Educational Officers. The controlling officers/District Educational Officers are directed to admit the newly appointed Junior Superintendents in concerned DTBDs and then relieve with direction to report for duty before the controlling officers concerned in which their service are deployed on the same very date.
- 3) Officers who are promoted to the cadre of the Junior Superintendents/Noon Meal Co-Ordinators/Noon Meal Officers/Store Keepers and Head Clerks will be on probation for a period of one year w.e.f the date of joining duty within a continuous period of two years.
- 4) The Head of office concerned are directed to relieve the incumbents and instruct them to report for duty in the new station or office immediately.
- 5) Report of joining duty/relief of officers will be forwarded to this office in time by the Controlling Officer.
- 6) The provisional promotions in the cadre of Junior Superintendents/Noon Meal Co-Ordinators/Noon Meal Officers/Store Keepers and Head Clerks are liable to be changed if any discrepancy found.
- 7) The next promotion of the Head Clerks as Junior Superintendents/Noon Meal Co-Ordinators/Noon Meal Officers/Store Keepers will be considered only after joining duty as Head Clerk in the station.
- 8) The promotion of Junior Superintendents/Noon Meal Co-Ordinators/Noon Meal Officers/Store Keepers and Head Clerks is purely provisional.
